

TOWN OF MONROE

Ordinance No. 2010 - 2

SHORT TITLE: An ordinance authorizing the posting and enforceability of stop signs at intersections in the Town of Monroe.

WHEREAS, the Town Council of the Town of Monroe heretofore duly enacted various ordinances which authorized the placement and enforceability of stop signs at intersections within the Town of Monroe; and

WHEREAS, the Town Marshal has reviewed copies of past ordinances and has expressed concern to the members of the Town Council of the Town of Monroe that not every posted stop sign within the Town of Monroe has been authorized by a duly adopted ordinance; and

WHEREAS, the Town of Monroe now finds that it is necessary, out of an abundance of caution, for the town to adopt an Ordinance which authorizes the placement and enforceability of stop signs within the Town of Monroe, now therefore:

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MONROE, ADAMS COUNTY, INDIANA:

Section 1. PURPOSE. The purpose of this Ordinance is to regulate compliance with the stop signs directing the flow of traffic on public streets within the Town of Monroe for the protection of public health, safety and welfare.

Section 2. ENFORCEMENT. Whenever a stop sign is erected at or near an intersection in the Town of Monroe, every operator of a vehicle shall come to a complete stop: (a) parallel to the stop sign; (b) before a marked stop line; OR (c) before a marked crosswalk prior to cautiously entering the intersection, yielding to any vehicles not required to stop.

This Ordinance shall govern stop signs erected at the following intersections within the Town of Monroe:

Jackson Street and Polk Street  
Jackson Street and Studebaker Street  
Jackson Street and Adams Street  
Keller Street and Andrews Street

Jackson Street and Van Buren Street  
Jackson Street and Keller Street  
Polk Street and State Road 124  
Keller Street and State Road 124



Andrews Street and Center Street  
Andrews Street and Park Street  
Adams Street and Christner Street  
Adams Street and South Street
